2. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in, Public Procurement Act, 2063 and Public Procurement Regulation, 2064 of Government of Nepal.

A complete set of bidding documents (Hard Copy) in English may be purchased on or before **6 October, 2016 from Department of National Parks and Wildlife Conservation, Babarmahal, Kathmandu** by eligible Bidders on the submission of a written application accompanied by a letter of Authority from the Principal/Manufacturer to the address above, along with the copy of Company/Firm Registration Certificate, and upon payment of a non-refundable fee of NRs. 3,000/-.
5. Sealed bids must be delivered to *Department of National Parks and Wildlife Conservation, Babarmahal, Kathmandu* at or before **12:00** hours on or before **7 October, 2016**. Bids shall be valid for a period of **90 days** after the deadline of bid submission. All bids must be accompanied by a bid security of amount mentioned above **NRs 300,000.00, valid 120 days beyond Bid validity**. The bid security may either be in form of a bid security issued by an authorized bank or cash deposited in Nepal Rastra Bank, Thapathali, Kathmandu, Account No. 1201200001002524 on behalf of Department of National Parks and Wildlife Conservation, Babarmahal, Kathmandu.
